WHEREAS, the Board of Directors is the governing board for the Olivehurst Public Utility District wastewater treatment facilities and collection system; and

WHEREAS, the Olivehurst Public Utility District intends to submit Financial Assistance applications for grants, loans, or other financing with the State Water Resources Control Board for funding;


BE IT RESOLVED by the Board of Directors of the Olivehurst Public Utility District that the General Manager is hereby authorized and directed to sign and file, for and on behalf of the Olivehurst Public Utility District, a Financial Assistance Application for a financing agreement from the State Water Resources Control Board for the planning, design, and construction of the Olivehurst Public Utility District Energy Savings and Solids Improvement Project; and

BE IT RESOLVED, that the Olivehurst Public Utility District hereby agrees and further does authorize the aforementioned representative or his/her designee to certify that the Agency has and will comply with all applicable state and federal statutory and regulatory requirements related to any financing or financial assistance received from the State Water Resources Control Board; and

BE IT RESOLVED that the General Manager or his/her designee of the Olivehurst Public Utility District is hereby authorized to negotiate and execute a financial assistance agreement from the State Water Resources Control Board and any amendments or change orders thereto and certify financing agreement disbursements on behalf of the Olivehurst Public Utility District.




