He said that once it is complete, the changes to the Board seats for current voting standards to ward based voting standards will become effective for the 2022 election. He stated that there is a new proposed Senate Bill that would force Districts to move to ward based voting and that the new boundary maps must be adopted by the Board by November 1, 2021.
