Item description/summary:

Purchase of an LP XDT Vacuum Excavator for water meter install project. This item was discussed in committee. We have an IRWMP/YWA grant for the installation of the remaining 400 some water meters in the District. However, when we received bids for the project they were twice the amount we have for the grant. We contacted the Yuba Water Agency and the State to inquire if we could complete the project in-house for the budgeted grant amount and if we were able to purchase the Vacuum Excavator with grant funds.
