#### Item description/summary:

Property/Liability Insurance Increase. SDRMA has provided the District's property/liability insurance since 2009. Requirements for coverage eligibility include CSDA membership (\$7,252/annually) and JPA pool membership. SDRMA has more than 500 members and offers additional risk management services to members (e.g. Target Solutions). The JPA claims to offer insurance coverage at 15% below commercial market rates. The annual increase in rates is shown in the Fiscal Analysis section. The 2020/21 proposed rate increase will double the District's insurance cost.

**Insurer Options:** 

California Rural Water Association offers coverage through MemberGuard. A request for proposal was submitted directly to MemberGuard. Interwest Insurance in Marysville offers coverage through Glatfelder Public Practice. The application for a proposal was submitted the broker.
